# 1. Funding request support

#### **UNAIDS**

<u>UNAIDS Technical Support Mechanism (TSM)</u> is a country-driven mechanism that operates in all regions but mainly in the East and Southern Africa, West and Central Africa, and Asia and Pacific region(s). TSM provides high-quality, short-term technical assistance to countries to support the development of data-informed, evidence-based Global Fund funding requests, as well as the removal of bottlenecks in grant implementation to effectively respond to the HIV epidemic. Thus, TSM support is throughout the grant cycle, including for the building blocks. # Roll Back Malaria (RBM)

The RBM Partnership to End Malaria provides support to Malaria Programmes and partners in the process of Funding request.

- Organize orientation meeting and provide guidance on the different GF application tools, new policy guidances from WHO and additional gap analysis tools.
- Provide technical support to complete the recommendations from TRP, and other documents including MPR and NSP in collaboration with WHO.
- Provide technical support through international consultants.
- Cover the cost of local consultants, in- country consultations and dialogue.

- Organize mock TRPs and provide expert review of the FRs.
- Provide technical support during grant making process and iterations.

Country programmes can directly send their needs any time they need TA through RBM.

#### **World Health Organization**

#### **Proposal development**

To aid countries in developing their proposals, WHO can support countries to:

- Review their performance (through joint monitoring missions and epidemiological assessments), identify gaps and weak links to strengthen, prioritize and cost interventions.
- Strengthen their strategic plans and investment cases the basis for all Global Fund funding decisions – to ensure that they are technically sound, feasible to implement and impact-oriented.
- Prioritize interventions to maximize the impact of limited resources and helps them to draft technically sound funding requests.
- To review funding applications by organizing peer and expert reviews to ensure that proposals are technically sound and will have an impact on a country's epidemics.
- Convene country dialogues to ensure that funding requests reflect country priorities.

#### **Grant-making**

WHO can assist countries in obtaining grants by:

- Supporting countries to develop detailed budgets and workplans, monitoring and evaluation plans, and procurement and supply-chain management plans.
- Identifying priorities, assessing risks, and developing sustainable financing strategies.
- Supporting grant negotiations by making technical staff available to participate in the negotiation process, thus ensuring that countries maintain technically sound interventions in the final grants.
- Provides normative guidance, tools, etc. as reference to ensure grants are negotiated based on the best available technical guidance.

#### **Grant implementation**

To ensure successful implementation of grants, WHO can:

- Help countries to develop annual workplans for their disease programs and monitor the progress of implementation, including facilitating annual reviews and strategic mid-term reviews.
- Support countries in identifying and resolving implementation bottlenecks.

- Provide information on new technical norms and standards and helps countries to update policies and guidelines according to the local context, as well as build capacity to effectively implement their programs.
- Facilitate the transfer of knowledge and skills, to progressively expand national institutional and staff capacities for effective implementation.
- Create regional forums for peer-to-peer learning and south-to-south experience sharing.
- Strengthen local health policy expertise through WHO collaborating centers.
- Help countries to collect and analyze their health data and use this information to improve their program's performance and make evidence-based decisions.
- Compile and analyze national, regional and global health data and makes these data available to all stakeholders, including the Global Fund; and
- Support countries to anticipate and address future health scenarios.

Lancée fin 2011, L'Initiative est une modalité française complémentaire du Fonds mondial. #### **English version**

Launched at the end of 2011, L'Initiative is a French facility that complements the Global Fund's work. It provides technical assistance and support for innovation to Global Fund recipient countries to improve the effectiveness of grants and strengthen the health impact of the programs funded. As such, it contributes to ensuring the effectiveness of the response to pandemics.

Among the 48 countries eligible for support from L'Initiative are the 19 priority countries for French official development aid. L'Initiative's recent work has demonstrated its catalytic effect through building the capacity of health and civil society stakeholders, improving institutional, political and social frameworks, supporting innovative approaches to respond to pandemics and strengthening systems for health.

It is implemented by Expertise France, the international technical cooperation agency.

#### **GIZ**

BACKUP Health provides technical support to focus countries through all the stages of the Global Fund grant cycle primarily to strengthen health systems (RSSH). During funding request development, in-country partners, both state and non-state, are supported in organizing and conducting robust and inclusive country dialogues to generate consensus on the countries' priorities for inclusion in the grants. Partners are supported to generate the relevant evidence needed to formulate policies/strategies and experts are deployed to support the proposal writing process. During grant making, partners are supported to define ideal implementation arrangements and roadmaps that will enable efficient implementation of the grants. Partners receive support throughout the implementation cycle of grants in the form of capacity development, evidence generation, catalytic gap-filling and exploring innovations for potential scale-up. These supports are provided in a variety of ways such as direct advisory support by BACKUP advisors, engagement and deployment of external

experts for technical support or development of policy documents/operational tools, and financial support.

# Types of support BACKUP is willing to provide for countries in the ongoing country dialogues and/or for the funding request:

- Support/ strategic advice for RSSH assessments, gap analyses and prioritisation of interventions in focus countries
- Advisory to promote inclusion and support participation of civil society and key populations in country dialogues and proposal writing
- Provide strategic advice to ensure evidence informed CSS strategies and gender sensitivity human rights are cross-cutting themes across the proposals.
- Deployment of technical experts to support thematic working groups for development of RSSH and cross-cutting disease interventions and writing of proposal.
- Advisory for promotion of integration, alignment and building synergies across disease grants.

#### The process for accessing this support:

Country dialogue and funding request processes: In focus countries, BACKUP advisors engage closely with CCMs, PRs and other partners to jointly identify potential areas of support through an iterative and collaborative process. This is guided by roadmaps developed by the countries/CCMs for the proposal development process and mapping of resources from the different partners supporting the FR process to ensure synergies and complementarities. Mode of support is discussed and agreed jointly with the primary beneficiaries of the support (e.g., CCMs, CSOs, government agencies).
