

TERMS OF USE OF THE GLOBAL FUND PARTNER PORTAL

(Issue Date: April 2021)

The Global Fund to Fight AIDS, Tuberculosis and Malaria (the "Global Fund") licenses, operates and makes available the Partner Portal accessible at "www.portal.theglobalfund.org" (the "Portal"). The Portal may contain features including RSS feeds, e-mail alert services, cookies, document management features, data management features, multi-factor authentication requirements for verification of banking details, and other applications that may be available from time-to-time (collectively, the "Features"). Any person that accesses or uses the Portal or Features, or both (the "User" and together, the "Users") agrees to be bound by the terms and conditions of these Terms of Use of the Global Fund Partner Portal (the "Terms of Use"), as they may be amended from time-to-time. These Terms of Use contain important conditions, disclaimers and other provisions, some of which limit the Global Fund's liability. If you do not agree to these Terms of Use or cannot enter into or do not have the capacity to enter into a legally binding agreement, you must not access or use the Portal or any of the Features.

APPROPRIATE USES

The Global Fund operates and makes available the Portal as a service and resource for the benefit of Users. Any use of the Portal by Users that actually or potentially limits or constricts the availability or quality of these services and resources is prohibited and the Global Fund reserves the right to take any actions required to enforce this principle.

Users may provide information as part of the registration process to access and use the Portal or the Features, or both. Information provided for registration must be accurate, correct and up-to-date.

As a condition of the use of the Portal and the Features, the User must:

- a. not use the Portal to upload, save, post or submit unlawful, defamatory, abusive, obscene or offensive materials;
- b. not access or attempt to access the Portal or Features using interfaces aside from the ones provided by or through the Portal;
- c. not use the Portal or Features in any way that may violate third-party rights including copyright, trademarks or privacy.
- d. not use the Portal or Features for any purpose that is unlawful under any applicable law or prohibited by these Terms of Use;

- i. not use the Portal or Features in any manner that disrupts the operation of the Portal or Features, or the business or the website of the Global Fund or any other entity;
- j. not use the Portal or Features in any manner that harms minors;
- k. not promote any unlawful activity;
- l. not represent or suggest that the Global Fund endorses any other business, product or service unless the Global Fund has expressly agreed to do so in writing;
- m. not use the Portal or Features to gain unauthorised access to or use of computers, data, systems, accounts or networks;
- n. not attempt to, or actually, circumvent security controls, user authentication methods or share passwords with anyone;
- o. report immediately to the Global Fund any abuse of the Portal or any Feature,



- suspicious behaviour, security breach or violation of these Terms of Use (see below further details on "Reporting to the Global Fund"); and
- p. take all necessary actions prior to collection of Personal Data (as defined below) and at all times subsequently, to ensure that the processing of Personal Data by the User does not violate these Terms of Use or any applicable law or regulation.
- q. read, understand and comply with the following documents, as may be applicable to the User:
 - a. "Code of Conduct for Recipients of Global Fund Resources" (as maybe updated from time-to-time);
 - b. "Code of Ethical Conduct for Country Coordinating Mechanism Members"² (as maybe updated from time-to-time);
 - c. "Code of Conduct for Governance Officials" (as maybe updated from time-to-time):
 - d. "Code of Conduct for Suppliers" (as may be updated from time-to time);
 - e. "Sanctions Panel Procedures Relating to the Code of Conduct for Suppliers" (as maybe amended from time-to-time); and
 - f. Ethics and Conflict of Interest policies, frameworks and procedures⁶ (as maybe updated from time-to-time).

DATA QUALITY

Information provided by Users through the Portal are used by the Global Fund for grant life cycle process management and decision-making. Therefore, Users must undertake all actions necessary to ensure the quality of this information. This includes ensuring the completeness, accuracy and consistency of such information, as well as compliance with Global Fund requirements⁷, where applicable.

ACCOUNT, USERNAME AND PASSWORD

Users are provided with a unique username and password. Users must not share their username or password, or both with any other person. Users are solely responsible for maintaining the confidentiality of the username and password provided to them by the Global Fund and are fully responsible for any actions that originate from their username. Users must immediately notify the Global Fund of the theft, loss or suspected unauthorized use of their username or password. The use by Users of their username and password to access the Portal constitutes an acknowledgement and acceptance of these Terms of Use.

ASSUMPTION OF RISK/DISCLAIMER OF WARRANTIES

The Portal and Features are provided on an "AS IS" and "WHEN AVAILABLE" basis. The content and functionality of the Portal and Features, or both may be changed by the Global Fund at its sole discretion. The Global Fund makes no representation or warranty, whether

REPORTING TO THE GLOBAL FUND

DATA PROTECTION PRINCIPLES

- (1) Principles. The User acknowledges that the User's access and use of the Portal and Features must respect the following principles and rights ("Data Protection Principles"):
 - (a) Information that is used or could be used to identify a natural person ("Personal Data") will be: (i) processed⁹ lawfully, fairly and transparently; (ii) collected for specified, explicit and legitimate purposes and not further processed in a manner not compatible with those purposes; (iii) adequate, relevant and limited to what is necessary for the purposes for which they are processed; (iv) accurate and, where necessary, kept up- to-date; (v) kept in a form which permits identification of the individuals for no longer than is necessary for the purposes for which the Personal Data is processed; and (vi) processed in a manner that ensures appropriate security of the Personal Data; and
 - (b) Natural persons are afforded, where relevant¹⁰, the right to information about Personal Data that is processed; the right to access and rectify or erase Personal Data; the right to data portability; the right to confidentiality of electronic communications; and the right to object to processing¹¹.
- (2) Limitations. Where collection and processing of Personal Data by a User is required, the User must respect the Data Protection Principles:
 - (a) to the extent that doing so does not violate or conflict with applicable law or policy, or both; and
 - (b) subject to the User balancing the Data Protection Principles with other fundamental rights in accordance with the principle of proportionality, taking into account the risks to the rights and freedoms of natural persons.

PERSONAL INFORMATION

The Global Fund reserves the right to use the User's submitted email addresses and IP addresses along with associated usage patterns and computer configuration and other Personal Data and information, in order to tailor the Portal to the User's specific needs, offer information that may be of interest to the User, for analysis and other institutional purposes. INDEMNIFICATION CLAUSE

The User agrees to indemnify, defend and hold harmless the Global Fund, members of its Board, and its employees, agents, affiliates and partners from and against any and all losses, damages, liabilities and other costs in connection with any claims, damages or losses that are related to or arise in connection with any one or more of the following: (i) the Portal; (ii) any Feature; (iii) use of the Portal; (iv) use of any Feature; (v) any alleged or actual unauthorized use of the Portal or any Feature; (vi) any Portal content; (viii) any Feature content; and (ix) any alleged or actual breach or non-compliant conduct with respect to these Terms of Use by any User.

LANGUAGE

The official, legally enforceable language of this document shall be English. Any question of interpretation shall be resolved based on the English version of these Terms of Use and the User agrees that these Terms of Use be provided exclusively in the English language.

DISCLOSURE OF INFORMATION

The Global Fund reserves the right to disclose any User's Personal Data and other information, when required by law or when necessary to investigate potential illegal activities such as fraud, violations of the Terms of Use, or when otherwise necessary to protect the property, rights and safety of the Global Fund, Users or other third parties.

DISPUTE SETTLEMENT

Any dispute, controversy or claim arising out of or related to these Terms of Use, the use of the Portal or any Feature, or the breach, termination or invalidity thereof, or to any use of the Portal or any Feature by a User or of the content available on the Portal or any Feature, and the applicable licenses, shall be settled by arbitration in accordance with the United Nations Commission on International Trade Law ("UNCITRAL") Arbitration Rules. The User agrees to be bound by the arbitration award rendered as a final adjudication. The number of arbitrators shall be one. The appointment authority of such arbitrator shall be the International Chamber of Commerce International Court of Arbitration. The place of arbitration shall be Geneva, Switzerland. The language used in the arbitral proceedings shall be English.

PRIVILEGES AND IMMUNITIES

Nothing in or related to these Terms of Use or the use of the Portal may be construed as a waiver, express or implied, of the privileges and immunities accorded to the Global Fund under: (i) international law, including international customary law, any international conventions, treaties or agreements, (ii) any national laws, including but not limited to, the United States of America's International Organizations Immunities Act (22 United States Code 288), or (iii) under the Headquarters Agreement between the Global Fund and the Swiss Federal Council, dated 13 December 2004.

AMENDMENTS

The Global Fund may amend these Terms of Use at any time, and such amendments shall be effective immediately upon notice being provided to the User. Notice may be provided on the Portal itself or through publication on the Global Fund's website, and after provision of such notice, the User's continued use of the Portal or any of its Features will be deemed as acceptance of the amended Terms of Use. Consequently, the User must carefully review such notices and check the currency of these Terms of Use regularly from time-to-time.
