

COVID-19 Response: Continued Principal Recipient Reporting

2 April 2020

The following flexibilities for submission timelines and minimum requirements for completion and validation of defined Progress Updates and Disbursement Requests (PU and PUDRs) are in place:

- Cohort 1. PUs and PUDRs with reporting periods ending December 2019. The PU and PUDR full completion and validation as per the Global Fund guidelines are continued requirements for this cohort. A maximum of 30 additional days for submission, review and validation of PU/DRs is accepted. Final Global Fund validation deadlines are April 15th 2020 for PUs and May 7th for PUDRs respectively. The timelines will continue to be monitored and reported.
- Cohort 2. PUs and PUDRs with reporting periods ending March, April and June 2020. The PU and PUDR minimum completion and validation requirements have been defined and are outlined below. Where feasible, the Global Fund requires the full data sets to be provided as per original guidelines. A maximum of 30 additional days for submission, review and validation of PU/DRs is accepted. Final Global Fund validation deadlines are: July 15th, August 15th and October 15th 2020 for the respective PUs and July 31st, August 31st and October 31st for the respective PUDRs and final PUs respectively. The timelines will continue to be monitored and reported.
- **Cohort 3**. PUs and PUDRs with reporting periods ending September, November and December 2020. The PU and PUDR full and timely completion, submission and validation per the Global Fund guidelines are continued requirements for this cohort until further notice.
