**Dear Principal Recipient:** 

The Global Fund aims to continue to support countries to process requisitions efficiently and ensure products for the three diseases and COVID-19 are delivered as close to the promised dates as possible.

COVID-19 continues to impact health product supply globally. We <u>regularly update</u> our website to provide clarity on the supply security situation. As of 6 July 2020:

- The impact to manufacturing is moderate. Reduced pharmaceutical-related production
  in India has continued through the lockdown period, contributing to delays of 1-2 months.
  LLIN production is largely on track. While delays of at least 2 months are expected for
  diagnostics due to supplier constraints, there are currently no production delays for viral
  load or early infant diagnosis products.
- COVID-19 control measures at origin and destination are resulting in logistics disruptions. Suspended operations, flight delays and cancellations are contributing to routing and capacity constraints. Delivery delays of several weeks or more are currently expected.

## Procuring COVID-19 diagnostics

The Global Fund developed the Accelerated Order Mechanism (AOM), a rapid process to quickly process and approve requests for Abbott and Cepheid COVID-19 diagnostics allocated to eligible countries by the World Health Organization, within three days of receipt of requests. The Supply Operations Department will reach out to initiate an order when a country's <a href="COVID-19">COVID-19</a>
<a href="Response Mechanism">Response Mechanism</a>
funding request is received, but the order cannot be formally processed or issued until the funding is approved and grant funding has been earmarked in wambo.org.

Principal Recipients with approved funding under <a href="grant flexibilities">grant flexibilities</a>
may submit a request through wambo.org as soon as funding is confirmed.

## Procuring COVID-19 Personal Protective Equipment (PPE)

The supply situation for PPE continues to evolve on a near daily basis with extremely high global demand. The Global Fund has finalized agreements with partners to make PPE products most critical to the COVID-19 response available on wambo.org for all our Principal Recipients. PRs are strongly encouraged to start using this new procurement channel but can continue procuring PPE through local channels if: 1) they have received prior written approval from the Global Fund, 2) an open, competitive and transparent process is followed, and 3) Global Fund guidelines and policies for lead times, value for money and reliability for delivery of products of the same specification are maintained.

Countries with approved Global Fund <u>grant flexibilities</u> or <u>COVID-19 Response Mechanism</u> (C19RM) funding may purchase PPE products directly through wambo.org using the existing normal process.

Principal Recipients currently procuring through the Pooled Procurement Mechanism can login to browse and submit requisitions for all available COVID-19 PPE products using the normal process.

Principal Recipients not currently participating in the Global Fund's Pooled Procurement Mechanism will need to complete the necessary on-boarding forms to begin procuring through wambo.org and should reach out to <a href="mailto:Landy.Raoilison@theglobalfund.org">Landy.Raoilison@theglobalfund.org</a>, copying their Country Team, to begin the on-boarding process. Completing the registration takes approximately three weeks, and we have dedicated resources to expedite this process given the urgency of the supply situation.

Currently, if PRs and Global Fund requisition approvals are done within as fast as one week, the lead time for key PPE products are currently estimated to be as short as one to three months from receipt of request to delivery in country by air and approximately three to five months by sea freight. Countries with complex importation approvals or lengthy greenlight to ship processes should add additional weeks to their lead times as necessary. PRs should consider a mix of air and sea freight to optimize speed and freight cost.

The most up-to-date lead time information can be found in the Global Fund's <u>Category and Product-Level Procurement and Delivery Planning Guide: Indicative Lead Times</u>. We urge Principal Recipients to place orders as early as possible to avoid disruption in supply since ongoing freight and logistics challenges are resulting in substantial delays and cost increases.

Principal Recipients can browse the catalogue of currently available core PPE products in wambo.org. The range of products will be updated during August. PPE products supplied are in compliance with the regulatory standards of the founding members of the Global Harmonization Task Force (namely, EU, USA, Canada, Australia, and Japan).

## Support for current deliveries

The Global Fund, Stop TB/GDF and PSAs continue to assess every order for potential delays. Currently, 15% of orders face delays of more than thirty days, including 12% of orders in transit.

PRs should use available track-and-trace tools to monitor the progress of specific orders. Please consider 30 days delay as the threshold for escalation. The Global Fund, Stop TB/GDF and PSAs will work with Principal Recipients directly to review mitigation plans and adapt lead times to minimize disruption where delays of more than 30 days are expected.
