\*\*\* Commodities for Oxygen Supply for COVID-19 Response refers to products and equipment (and services, where applicable) designed and manufactured to ensure the use of oxygen as a medical treatment, and are stated in the Global Fund Health Product Management Template (HPMT) categories: Medical Oxygen - Consumables, Medical Oxygen - Liquid Oxygen and Medical Oxygen - Equipment. Examples of COVID-19 related Oxygen Products are nasal prongs, oxygen plants, non-invasive ventilators and oxygen concentrator.

\*\*\*\* This includes products, where the PSA invoices and price quotations the Reference Fee as a percentage of what the equipment, re-agents & associated ordered products (e.g. rental agreements' procurement) would have cost if the PR had bought the product.

Notes:

- The Reference Fee is expressed as a percentage of the total price of the products (excluding customs duty and other taxes, transport and insurance) based on the vendor's unit price stated on the purchase order. This excludes condoms and lubricants on which the Reference Fee is calculated based on the CIF value and not product value alone.
- For those requisitions in process during the implementation of the new fee structure there may be downward adjustments to the fees charged should it be material.
- The Reference Fee can change without prior notice, please check with the Global Fund PPM team for the latest information.
